

We inform you about the following agreement that was taken in the last meeting of the Teaching Commission of the Department of Information and Communications Technologies on 18 of July 2022:

"After being accepted to the PhD program, the assessment of the records of candidates of **the fourth period of application** and in accordance with the criteria of selection, it was agreed to grant PhD fellowships (predoctoral researcher contract's - PRC) for the year 2022-23 to the following candidate:

1. ID number: 53795677B (Spain) under the supervision of Dr. Anders Jonsson.
2. ID number: 76662916Y (Spain) under the supervision of Dr. Rubén Moreno Bote.
3. ID number: F49551049 (Chile) under the supervision of Dr. Carla Ràfols.
4. ID number: (Turkey) under the supervision of Dr. Narcís Parés* (*conditioned).
5. ID number: FB347105 (Ukraine) under the supervision of Dr. Ricardo Baeza Yates.

The fellowships (Predoctoral Researcher Contracts - PRC) are awarded according to the approved criteria and will have to accomplish the following requirements:

- The specific type of contract corresponding to each selected candidate will be agreed with the relevant supervisor.
- **PIPF1:** includes teaching assistance tasks (45 hours per academic year). Minimum monthly gross salary: 1.386,57€*
- **PIPF2:** includes teaching assistance (45 hours per academic year) and research tasks. Minimum monthly gross salary: 1.386,57€* (926,92€ funded by the Department + extra amount funded by the research project).
- The requesting supervisor acknowledges that, as with any other PIPF-1 or PIPF-2 grant, the teaching co-funding is subjected to the student adequately fulfilling his/her teaching duties, and would be immediately terminated otherwise. In such an unfortunate case, the requesting supervisor agrees to take the responsibility of seeking for the necessary funding for the student.
- After the first year, students must demonstrate oral proficiency in Spanish or Catalan level A2. - All fellowship holders (predoctoral researcher contract holders - PRC) must state their link to the ICT Department and to the UPF in their research.

Non-EU students will have a reduction of 24 % the three first months (till December, if the contract starts in October). The corresponding taxes will be deducted from January when the new fiscal year starts. () These amounts correspond to the wages of 2021.*
